NEW Action Plan "N/A" Descriptions

St. Clair County Road Commission:

BMP 3: The SCCDO and the SCCHD are planning to send letters to farms with problem areas.

BMP 8: The SCCHD takes care of distributing materials on Low-Impact Design.

BMP 11: The SCCHD and MSU-Ext take care of promoting the Adopt-A-Stream program.

BMP 13: The SCCHD and MSU-Ext take care of promoting the soil testing program.

BMP 14: The SCCMPC promotes the Citizen Planner Program to local units of government.

BMP 17: No problems have been indicated from golf courses.

BMP 18: The SCCHD promotes catch basin marking.

BMP 19: Storm water ordinances and natural feature protection ordinances will not be pursued by the SCC; however, updates to existing design standards and specifications will be pursued.

BMP 21: The SCCHD currently surveys IDEP on road drains. The RC role is to refer illicit discharges and promote the hotline.

on BMP 22: The SCCRC does not handle sanitary issues.

BMP 23/24: SCC does not have jurisdiction over any SSO or CSO.

BMP 25: Bathing Beach Monitoring Program implemented by the SCCHD.

BMP 26: Illegal dumping ordinance outside of SCC jurisdiction.

BMP 27: The SCCHD enforces the IDEP program under ordinance adopted in 2003.

BMP 28: SCC will wait until the first phase of its IDEP program is complete to explore a septic system maintenance program.

BMP 30: The RC plans to update its "Procedures for Plat Street Development" to reflect current development standards. It does not have the authority to regulate land use planning or develop ordinances.

BMP 32: The SCCMPC is currently updating the County's Master Plan.

BMP 33-36: These types of ordinances are implemented at the local level.

BMP 37: Does not pertain to the SCCRC's mission.

BMP 38-40: These types of ordinances are implemented at the local level.

BMP 41: RC identifies erosion problems along ditches and stream crossings as part of district foreman duties and provides a list of road stream crossing stabilized/ year to the SCCHD for annual storm water reporting. The RC cannot participate in any monitoring efforts beyond these routine evaluation duties.

BMP 42: The Parks and Recreation Commission (PARC) is currently identifying areas for riparian recreation enhancements.

BMP 43/44: Recreation plan for SCC updated by the Parks and Recreation Commission (PARC).

BMP 45: Hydrologic and hydraulic studies are performed on bridge replacements. Additional studies are beyond the scope of the Road Commission's jurisdiction.

BMPs 46-53: Outside of SCCRC's jurisdiction (although BMPs 47-49 are coordinated through the SCCMPC).

BMP 54: RC does not have control over land use development. The RC sits on a committee that is studying the feasibility of reducing impervious surfaces for SCC properties.

BMP 55: Composting ordinances are implemented at the local level.

BMP 56: The SCCDO removes flow obstructions.

BMP 58: The RC maintains oil and grease traps at the Central Service Center and submits inspection and maintenance records to the SCCHD for annual storm water permit reporting.

BMP 59: RC does not have control over land use development. The RC sits on a committee that is studying the feasibility of encouraging infiltration practices on SCC properties.

BMP 60: The SCCDO installs and maintains detention/retention systems.

BMP 61: There are very few road-side streams under the SCCRC's jurisdiction and none have been identified for in-stream restoration.

BMP 62: The width of the right-of-way does not allow for this practice. Vegetation in the right – of-way can cause a hazard for the motoring public by blocking vision and hiding obstructions.

BMP 65: Current activity includes: 1) stabilizing road ditch banks with seed and mulch, or seed and erosion control blankets after cleanouts, and 2) RC specifications that require stabilization of disturbed areas within four days of work.

BMP 66: This not a RC function.

BMP 68: This is not a RC function.

BMP 69: Vegetation in the right-of-way can cause a hazard for the motoring public by blocking vision and hiding obstructions. Trees in right of way are undesirable.

BMP 70: The SCCDO maintains the Stormwater Management Facilities included under BMP description.

BMP 73: Will be utilizing regularly scheduled housekeeping inspections and SEMCOG employee training program to improve housekeeping practices.

BMP 77: The SCCRC does not maintain sanitary systems.

BMP 80: The RC does not have the jurisdiction to enforce its standards and policies. It can only make recommendations or receive compensation for work performed within the road right-of-way.

BMP 82: The RC will not commit to future actions that are undefined at this point.
