**INTERGOVERNMENTAL AGREEMENT:**

**Section 4.01. County Authority Board Composition.** The County Authority shall be governed by the County Authority Board, a board of directors that shall be appointed within 30 calendar days of the Effective Date. Elected officials and other public officers are eligible to serve as members of the County Authority Board to the extent permitted under Michigan law. The County Authority Board shall consist of the following members, except as provided in 4.02:

- (a) The Treasurer.
- (b) One township or city official, located in St. Clair County, the appointment to the County Authority Board to be made by the County Board.
- (c) Three other County Authority Board member appointments to be made by the County Board and must be residents of St. Clair County.

**Section 4.03 Terms of Office.** The member under 4.01(b) initially shall be appointed for a period of one year. Of the members listed under 4.01(c), 2 members initially shall be appointed for a period of two years, and 1 member shall initially be appointed for a period of one year. After the expiration of the initial terms, members appointed under Section 4.01(b) and 4.01(c) shall be appointed in the same manner as the original appointments but for terms of three (3) years.
