

RESOLUTION 19-06

ADOPTING NEW FEE SCHEDULE FOR DOG LICENSE FEES AND REMUNERATION OF ISSUING AND RECORDING DOG LICENSES.

WHEREAS, the Board of Commissioners of St. Clair County, pursuant to M.S.A. 12.516, has the authority to prescribe the fees necessary to properly finance the Animal Control Program for the County of St. Clair, Michigan, and

WHEREAS, the current fee schedule has been in effect since January 1, 2019

NOW, THEREFORE, BE IT RESOLVED, that effective June 21, 2019, the following fee schedule shall be in effect:

ANNUAL LICENSE FEES: (applies to those dogs who have reached four (4) months of age - with a current Rabies Vaccination administered by an accredited veterinarian.


BE IT FURTHER RESOLVED, the Animal Control Director may alter this fee schedule for special events and promotions with approval of the Administrator/Controller.
