Carrigan and Grace Drain Drainage District (Owner) is requesting Bids for the construction of the following Project:

The Project includes the following Work:

Contract 1

Main Channel and Branch No. 2 – Division 1

Open Channel rehabilitation including approximately 82 stations of clearing and excavating drain, removing all debris from site, mowing or brushing the channel, 15 stations of non-mechanized drain clearing. Remove Meadowlawn Drive Crossing and furnish and install to replace with 60 feet of RCP Culvert per details. Cleaning out existing culverts, resetting and replacing private culverts as specified. Remove and dispose of culverts and side inlets as directed. Traffic Control & Detour and safety planning for roadside operations. Includes all appurtenances, components, products, grading, restoration and utility movements.

Keewahdin Branch – Division 2

Roadside drainage branch. 9 stations of non-mechanized drain clearing. Approximately 4.35 acres of clearing and grubbing drain right of way, removing all debris from site. Remove and Replace 206 feet of 72" Diameter CSP Culvert. Remove 16 private drive culverts and drive appurtenances and dispose of all. Furnish and install to replace culverts with 300 feet of 48" Diameter CSP, 60 feet of 42" Diameter CSP, 140 feet of 30" Diameter CSP and 286 feet of 24" Diameter CSP. Remove and furnish and install to replace existing storm sewer with 96 feet of 24" Diameter RCP pipe and enc section. Includes all appurtenances, components, products, grading, restoration and utility movements.

Grace Branch – Division 3

Subdivision drainage branch. Clear and Mow 5.63 stations (est. 0.52 acres) of Drain Right of Way, Clearing for Construction 9.74 stations (est. 1.34 acres) of Open & Enclosed Drain Remove and dispose of 712 feet 30" Diameter storm sewer/culvert. Remove and dispose of existing drainage structures (4 each). Excavate 3.61 stations on open channel. Dispose of spoils offsite. Furnish and install 647 feet of 30" diameter RCP storm sewer, 40 feet of 24" Diameter RCP storm sewer and 70 feet of 30" Diameter CSP storm sewer. Furnish and install 72" Diameter drainage structures (2 each). Includes all appurtenances, components, products, grading, restoration and utility movements.

Contract 2

Proposal Scoping, cleaning, repairing and lining of the identified reach of the Keewahdin Branch enclosure.
