The Reportable Disease Update has been developed to communicate infectious disease surveillance information to community healthcare professionals. This update will be distributed quarterly to identify and communicate issues, trends in the community, and emerging communicable diseases that can impact our community.

## Information Items:

- Gonorrhea cases are increasing in St. Clair County and are highest in those 20-24 years of age. Talking about sexual health is an important conversation between a patient of any age and their healthcare provider as it can identify opportunities for education and testing. STDs left undiagnosed and untreated can have serious health consequences, including infertility, life-threatening ectopic pregnancy, stillbirth in infants and increased risk of HIV transmission.
- It is not too late to get a flu vaccine! Respiratory illnesses are increasing and flu season is just starting. St. Clair County Health Department (SCCHD) recommends an annual flu vaccine for everyone 6 months of age and older. Appointments are available at SCCHD by calling 810-987-5300 or inquire about the availability at a pharmacy near you.
