2025 Annual Report Summary

St. Clair County Senior Citizens Millage

The Senior Citizens' Millage supports a coordinated system of services that helps St. Clair County residents age 60 and older maintain independence, health, and quality of life.

In 2025, **\$6,469,041** in millage funding supported **12 service providers delivering 28 programs** across the county, addressing essential needs including nutrition, transportation, in-home support, health and wellness, and social engagement.

Millage funding helps maintain and expand essential programs that support older adults' independence, health, safety, and overall well-being throughout St. Clair County. Services are available to older adults throughout St. Clair County through a coordinated network of local service providers.

Through this coordinated network, services reached older adults throughout St. Clair County, helping them remain independent, access critical resources, remain safely in their homes, and stay connected to their communities.

The Senior Citizens' Millage continues to provide a stable framework for supporting the independence, health, and well-being of older adults across St. Clair County. Services that support aging in place, mobility, accessibility, nutrition, wellness, and community connection also contribute to broader county priorities focused on healthy communities, housing stability, and overall quality of life.

SENIOR SERVICES

Senior services funded by the St. Clair County Senior Citizens' Millage are available to residents age 60 and older. Services are delivered through a coordinated network of local providers and may be offered at no cost, on a sliding fee scale, or for a suggested donation, depending on the program. To determine eligibility, residents should contact the appropriate service provider.

Service Area:

Regional Coordination & Grant-Funded Services

Overview:

Serves as the regional Area Agency on Aging, connecting St. Clair County to federal and state-funded programs that support older adults.

2025 Impact:

- Uses local millage funding to help secure additional state and federal funding for senior services
- Leverages additional federal and state resources to expand services available to county seniors

Community Impact:

Strengthens the senior service system by securing additional resources that expand programs and increase access to services for older adults in St. Clair County.

Health Care, Hospice & In-home Support

Overview:

Provides home care, hospice, respite services, and supportive programs to assist seniors and their families with medical, personal, and end-of-life care needs.

2025 Impact:

- 1,002 seniors served (*combined across programs*)
- 15,742 hours of service and 508 nights of care provided

Community Impact:

Supports seniors and their families by providing compassionate care, medical support, and comfort during times of illness, recovery, and end-of-life.

- 1,267 service hours and 134 shelter nights provided

Community Impact:

Provides safety, protection, and support for vulnerable seniors, helping them transition out of crisis situations.

- Delivered meals, transportation, in-home support, and community-based services
- **9,677 seniors served**
- **131,174 hours of service provided**

Overview:

- 82 nights of lodging provided

Community Impact:

Supports seniors and their families by reducing barriers to medical care and providing stability during times of medical need.

Overview:

Provides civil legal assistance and representation for older adults, addressing issues such as housing, consumer protection, public benefits, estate planning, probate services and elder abuse.

Protects the rights and stability of older adults by providing access to critical legal support and advocacy.

Community Impact:

Supports seniors with cognitive impairments by providing structured care, supervision, and daily support, helping maintain quality of life and offering relief for caregivers.

Ensures vulnerable seniors receive appropriate care, housing, food, and support through legal oversight and case management.

Program services are partially funded through St. Clair County Senior Citizens' Millage. Service Provider numbers are not audited.

FINANCIAL OVERVIEW

The Senior Citizens' Millage provides stable, locally controlled funding to support essential services for older adults across St. Clair County.

Millage Revenue

The Senior Citizens' Millage fund is supported by four primary sources: tax collection, interest income, Local Community Stabilization Act (LCSA) funds, and other service reimbursements.

In 2025, total revenue collected was **\$6,539,503**.

Revenue Breakdown

- **Tax Collection:** \$6,216,250
- **Interest Income:** \$171,038
- **LCSA Funds:** \$120,935
- **Other/Reimbursements:** \$31,280

Millage Expenditures

The Commission on Aging reviews funding requests and makes recommendations for service provider allocations. The St. Clair County Board of Commissioners adopts the Senior Citizens' Millage budget annually as part of the County's Special Revenue Funds.

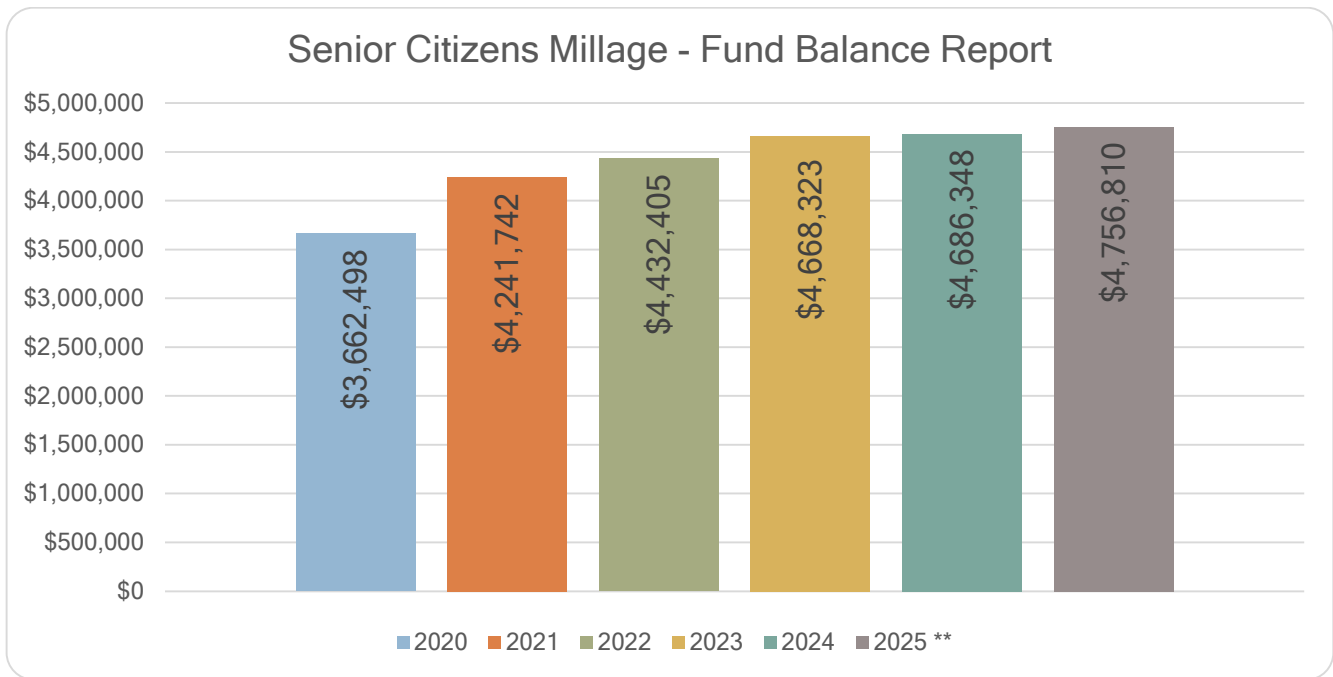
Fund Balance

Fund balance represents the accumulation of operating surpluses over time. These funds may be used for ongoing operations, special requests, new services, or to temporarily sustain programs if the millage is not renewed.

The fund balance increased by **\$70,462** from 2024 to the 2025 pre-audit projection.

At its current level, the fund balance could support existing services for approximately **eight months**. It remains Administration’s recommendation to maintain a **six- to seven-month operational fund balance** as a best practice.

A recent history of the Senior Citizens’ Millage fund balance is shown below.



Note: Fund balance amounts are based on audited figures from the County of St. Clair Comprehensive Annual Financial Reports, with the exception of 2025, which is unaudited.

Independent Auditors

The Senior Citizens Millage fund is audited annually as part of the County of St. Clair’s independent financial audit. The current auditor is **UHY LLP, Certified Public Accountants**.

LOOKING AHEAD

The St. Clair County Senior Citizens' Millage will continue to play a vital role in supporting programs and services that meet the evolving needs of older adults.

Through ongoing collaboration with service providers and continued community engagement, the millage supports a coordinated system focused on independence, health, and quality of life for residents age 60 and older.

As the needs of the community change over time, the Commission on Aging will continue to evaluate programs, identify service gaps, and make recommendations that ensure responsible use of millage funds and continued access to essential services.

OVERVIEW

History of the Millage

Public Act 39 of 1979 authorizes local units of government in Michigan to establish a Senior Citizens' Millage to fund services and programs for older adults. A special election held on September 11, 1979 established the St. Clair County Senior Citizens' Millage at 0.4 mill, generating \$492,605.

Over time, the millage rate has been increased twice: to 0.5 mill in 1986 and to 0.8 mill in 2012. In 2022, the rate was rolled back to 0.7983 mill in accordance with the Headlee Amendment. The Headlee Amendment requires millage rates to be reduced when property value growth exceeds inflation, ensuring that overall tax revenue growth remains aligned with inflation.

The Senior Citizens' Millage has consistently demonstrated strong community support and remains an essential funding source for senior services across St. Clair County. In 2022, over 78% of voters approved the renewal for the 2022-2025 period.

The Senior Citizens' Millage is scheduled to appear on the **August 4, 2026 Primary ballot** as a renewal of the existing millage for a four-year period from 2026 through 2029.



About Us – Commission on Aging

The Commission on Aging (COA) was established in 1979 as an advisory board to the St. Clair County Board of Commissioners. The Board of Commissioners appoints nine members to the COA, each serving three-year terms. Members represent each of the seven Board of Commissioners' districts and must reside in the district they represent. Two at-large members may reside anywhere within St. Clair County.

Mission Statement

The Commission's purpose is to recommend prudent use of public funds from the Senior Citizens' Millage and to coordinate programs and services that meet the changing needs of St. Clair County residents age 60 and older, promoting their well-being and quality of life.

Duties and Responsibilities

The duties and responsibilities of the Commission on Aging include:

- Staying informed on issues affecting seniors in St. Clair County
- Educating the public on resources available through the Senior Citizens' Millage
- Making recommendations to the Board of Commissioners regarding senior services and the annual millage budget
- Monitoring the expenditures of millage-funded service providers
- Seeking proposals for new services as the needs of seniors in St. Clair County evolve
