The Federal and State tax deductions for retiree and beneficiary pension payments have been updated to reflect 2026 IRS tax tables. If you notice a slight difference in your net retirement payment beginning January 2026, it is likely due to a change in the new tax tables. ### MI Phasing Out State Tax on Most Retirement and Pension Benefits

Michigan is **phasing out its state tax on most retirement and pension benefits**, with a full repeal effective for the 2026 tax year and beyond. The change, enacted as the "Lowering MI Costs" plan (Public Act 4 of 2023), reverses a 2011 law that made more retirement income taxable.

#### Some Key Details of the Repeal

- **Phase-in Period**: The tax repeal was gradually implemented over four years, starting with the 2023 tax year. The amount of retirement income you can deduct increased each year.
- **Full Exemption in 2026**: For the 2026 tax year, most pensions, 401(k) withdrawals, and IRA distributions will be fully exempt from Michigan's state income tax, similar to the rules that existed before the 2011 law change.
- **Public Safety Retirees**: A special provision allowing retired police officers, firefighters, state troopers, and county corrections officers to fully deduct their public pension benefits without any age requirement or cap, was effective from the 2023 tax year.

#### **Next Steps for Retirees**

- <u>Consult a Professional:</u> Due to the complexity of the phase-in rules, the Michigan Department of Treasury and financial advisors recommend consulting a qualified tax preparer to ensure you claim the maximum eligible deduction.
- **Stay Informed**: For the most up-to-date information, refer to the official <u>State of Michigan</u> website on retirement and pension benefits.
- **Adjust Withholding**: You may wish to update or discontinue your State of Michigan tax withholding from your pension payment as advised by your tax preparer.

If you wish to opt-out of Michigan State withholdings, you must complete and submit the "State of Michigan W4P Withholding Form for Pensions," which can be found on the County Website under Retirement > Forms. Your tax preparer can help you complete your new form.
