Medicare Part B

Medicare Part B covers physician services, outpatient hospital services, certain home health services, durable medical equipment, and certain other medical and health services not covered by Medicare Part A. Each year the Medicare Part B premium, deductible, and coinsurance rates are determined according to the provisions of the Social Security Act. The Centers for Medicare & Medicaid Services (CMS) will announce the 2025 Medicare Part B premium in the fall of 2024. However, projections suggest that the premium will increase to around \$185 per month, which is a 5.9% increase from 2024. *CMS.gov. This is not a cost that comes from St. Clair County or effects your pension.
