# **Blue Water River Walk**

Work on restoring the St. Clair River shoreline south of the Black River has begun. In early September, workers began removing tons of materials left behind from the industrial era over the last 100 years. Approximately 300 feet of shoreline will be restored to create a more natural appearance and habitat for wildlife.

The work in this first phase is being funded by a \$250,000 grant from the U. S. Fish & Wildlife Service. The Community Foundation of St. Clair County has also received a second \$2,000,000 grant from the National Oceanic and Atmospheric Administration's (NOAA) Great Lakes Habitat Restoration Program. The NOAA grant will fund additional shoreline

restoration beginning in early 2013.

"In addition to state and federal grant funds and the generous gift of land from Jim Acheson, the Community Foundation has received over \$200,000 from individual and corporate donors to support the construction of a multi-purpose pedestrian trail in 2013. The Foundation's lead gift came from First Preferred Mortgage/Michigan Mutual. They were quickly joined by many others including Dr. Bassam Nasr, a local physician and member of the Foundation Board. Dr. Nasr was one of the first people to commit a generous financial gift to the project. Through his leadership, and that of corporate partners like First Preferred, the Blue Water River Walk has made significant progress."- Randy Maiers, President Community Foundation of St. Clair County



In 2013, the City of Port Huron will construct an asphalt trail from 10th Street to Military Street, at the same time that the Community Foundation expects to construct its section of trail from the Military Street Bridge north along the St. Clair River to the Great Lakes Maritime Center. The City and the Community Foundation hope to use separate Federal Transportation Enhancement grants provided by the Michigan Department of Transportation.

Once the project is completed, it will add over 1.2 miles of paved trail to the Bridge to Bay Trail system.

# County Park Property on the Waterfront

In August, St. Clair County was notified that the State Legislature and the Governor approved its \$150,000.00 acquisition grant from the Michigan Natural Resources Trust Fund to purchase 2.75 acres of vacant land located just north of the Seaway Terminal from Acheson Ventures. The property purchase is expected to be completed this winter and will connect the City of Port Huron's trail to the Blue Water River Walk. St. Clair County Parks and Recreation millage funds will be used for the local match for the project.

## **Smoke-Free Playgrounds**



This fall, signs are being posted around the children's playgrounds at Fort Gratiot County Park and Goodells County Park thanking visitors for not smoking around "Young lungs at play!" Signage will also be posted around the Goodells Splashpad next summer. The signage and posts were purchased with funding the St. Clair **County Health Department** received through the Michigan Department of

Community Health's Tobacco Reduction Program. Park staff provided the labor and equipment to install the signs. Dr. Annette Mercatante, St. Clair County Health Department Medical Health Officer stated "the concept of smoke-free (or tobacco-free) beaches and parks is growing in popularity around the state and nation. Not only does it reduce the amount of cigarette litter and secondhand smoke exposure, it also provides positive role modeling for youth".

# **China Township's New Playground**

Children in China Township have a new place to play, as new playground equipment was recently added at the Indian Trail Park site. The new accessible playground includes features like safety swings, a teeter-totter, a bouncee, and spinner. The playground equipment and safety surfacing cost \$18,000, with most of the cost being covered by the St. Clair County Parks and Recreation millage distribution program. The township covered the remaining funds.

Future plans to add updated playground equipment at the "Larry Neiman Memorial Park" at the Township Hall Site are underway.





## **Ira Township adds Disc Golf Course**

A new disc golf course has been established in Ira Township and is getting rave reviews from the public. According to Don Van Houtte, a volunteer who has donated personal time in developing the course, "The public likes how the course has retained the natural settings of the park and enjoy the exercise that they get from traversing through the course." Don added, "The Ira Township Parks department has been easy to work with and are great people."

Due to growing popularity, a second course in East China Park is also nearing completion. "People have been checking it out and are excited to give it a try", added Van Houtte. Future plans call for the East China course to be expanded to 18 holes.

# **Fort Gratiot County Park**

#### **Reservations for 2013**

A summer of record high temperatures brought thousands of visitors to swim in the WARM waters of Lake Huron and enjoy the facilities at Fort Gratiot County Park. Ninety-two families and groups reserved the two park pavilions this year. Both pavilions were booked every weekend. This fall, twenty-eight reservations have already been booked for 2013. # **Coastal Management Grant**

Soon contractors will begin repairing historic sidewalks and adding new ADA accessible walkways thanks to a \$30,172 Coastal Management matching grant. The grant also includes nine low-profile interpretive signs that will be installed along the new accessible pathways.

The new pathways will link the current parking area to the Light Tower and provide access from the Fog Signal Building to a plaza that will provide views of Lake Huron and the Light Tower. A second plaza will be built adjacent to the parking area near the former Coast Guard Station. New interpretive panels and benches will be installed at both plazas.

The \$60,344 project is expected to begin in late October and be completed around the first week of November. St. Clair County Parks and Recreation Commission is providing the grant match.



# **Light Station is a Hit in 2012**

In 2012, visitors could not wait for a chance to climb the 94 steps to the top of the newly restored Lighthouse. In fact, over 13,000 visitors came to the Light Station during the first five months! Visitors were treated to tours of the Lighthouse and grounds, lead by the staff and volunteers of the Port Huron Museum. Visitors were also able to browse in the new gift shop located in the Fog Signal Building. The Museum will operate tours and the gift shop Friday through Monday, 11:00 a.m. to 5:00 p.m. through December 16th. Overnight programs in the Keeper's Duplex Building are offered throughout the year. For more information, call the Museum at (810) 982-0891.

#### 2013 Roof Work

When St. Clair County Parks took control of the Fort Gratiot Light Station in 2010, the federal government required that County Parks maintain and protect the historic structures as part the transfer agreement. To maintain the buildings, County Parks has been successful in procuring grant funding for restoration and stabilization projects. Those grants have funded the restoration of the Light Tower, the Fog Signal Building roof and door replacement and a new roof on the Equipment Garage.

In 2013, County Parks will be eligible for a another Michigan Lighthouse Assistance Program (MLAP) grant. The goal is to remove and replace the failing asphalt shingles on either the former Coast Guard Station (1932) or Keepers Duplex (1874). An application requesting a \$20,000 matching grant will be submitted later this fall.

# **Cyclocross at the Park**

On September 16, 145 riders gathered at Columbus County Park to participate in the first Cyclocross event ever held in St. Clair County. Cyclocross is a unique and challenging sport that combines off-road bicycling over rolling terrain with obstacles that force riders to dismount and run while carrying their bikes. In order to make the race as challenging



as possible, the course made full use of the grass covered sledding hills at the park. The Columbus County Park race was the first event in a fall series that travels to Kensington Metro Park, Lower Huron Metro Park, Lake Orion High School, Waterford Hills and finishes at Addison Oaks County Park on December 16. After a couple years of discussions and planning, members of the Michigan Mountain Biking Association have begun to layout and construct beginner mountain biking trails in Columbus County Park west of Kronner Road. Todd Powers is coordinating the trail building effort that will kick off on Sunday, October 21, with a work session from 10 am to 3 pm.

When completed, the mountain biking trails will also be open to walkers, and runners. Additional phases of trail development in the coming years will include the development of intermediate trails.

# **Hunting Season At Columbus**

For the 4th year, hunting is being allowed by special permit in parts of Columbus County Park. Hunting is only allowed in the areas of the park located south of the Belle River, west of Kronner Road, and a small area immediately east of Kronner Road. HUNTING IS NOT ALLOWED IN THE MAIN PART OF THE PARK LOCATED OFF OF BAUMAN ROAD AND NORTH OF THE BELLE RIVER.

All registered hunters are required to carry their permit with them at all times. Hunters also must post their metal ID tag on the Hunter Boards located at both the Big Hand Road and Kronner Road parking lots.

All park users are encouraged to wear colorful (preferably orange) clothing during hunting seasons. All hunting questions should be directed to the main office at (810) 989-6960.

# **Bridge to Bay Trail**

# St. Clair Township

In September, the St. Clair Township Board approved a \$597,164.94 contract with Boddy Construction of Port Huron to construct another section of the Bridge to Bay Trail. The ten-foot wide asphalt trail will be built on the west side of M-29, from Yankee Road north to the existing trail in front of the axle plant on Davis Road. The nearly two mile trail is expected to be completed this fall. The St. Clair County Parks and Recreation Commission has committed \$20,000.00 in St. Clair County Parks and Recreation millage funds to the project.



# **Trail Signs**

A contract is expected to be awarded in November to install the first phase of improved and standardized signs along the Bridge to Bay Trail from Marine City



to St. Clair. Additional contracts will be awarded in future years to complete other sections of the trail. All trail signage improvements are being funded by the St. Clair County Parks and Recreation millage.

# **Accessibility on Trail Improved**

In order to comply with the evolving Americans with Disabilities Act (ADA) rules, the Wadhams to Avoca Trail access bollards located at each road crossing and trailhead will be re-aligned to allow disabled trail users to access the trail. Currently, two operable bollards are spaced 36 inches apart in the middle of the trail. In the coming year, the two bollards will be replaced with a single operable bollard located in the middle of trail. In the meantime, one of the operable bollards has been removed at each location.

Disabled trail users are asked to carry their State of Michigan handicapped parking permit with them when they use the trail. All trail users are asked to be courteous to other trail users.



# **Wadhams Crossing**

This fall, engineers from DLZ are reviewing, analyzing and updating the Wadhams Road trail crossing signals that were installed in the fall of 2009. So far, the auditory pedestrian signals have been adjusted and trail user and road counts are being conducted to re-affirm that the signals are still needed. Other crossing improvements resulting from the study are expected to bring the crossing into compliance with 2012 standards. The trail crossing study is being funded by the St. Clair County Parks and Recreation millage and supervised by St. **Clair County Road Commission** engineers.

## **Trek The Trestle 2012**

On September 3rd, 2012 about 200 people came out to the Wadhams to Avoca Trail with the same goal, to"Trek the Trestle!"

The five mile walk event celebrated its fifth year of being part of the Labor Day Community Walks sponsored by The Governor's Council on Physical Fitness.

Walks are important steps toward helping citizens lead healthier, more physically active lives. By participating in the walk, St. Clair County residents and their guests were able to demonstrate their commitment to healthy living, physical activity and community involvement.




