

Fort Gratiot County Park Opens New Non-County Parking Booth

Earlier this spring, a change was implemented at the entrance to Fort Gratiot County Park. In order to make the park more accessible to all St. Clair County residents, a new parking booth was installed. Residents of St. Clair County will continue to have free parking. County residents will receive a window decal upon entry with proof of residency to be displayed on their windshield for free parking.

Non-county residents will pay a parking fee of \$20 per day, per vehicle. The parking fee will be collected from Memorial Day weekend through Labor Day weekend. Fees for out-of-county residents will be charged Friday through Sunday and on holidays during the park's summer hours. Cash and credit card payments are accepted at the booth. Parking passes are non-refundable and only issued upon arrival at the park.



North Channel County Park Grant Updates

St. Clair County Parks recently received one grant for the new North Channel County Park in Clay Township, and applied for three more. Notification of the Michigan Natural Resource Trust Fund award was made public earlier this year, with the official grant agreement expected to arrive in early August. The \$270,000 Trust Fund grant with \$280,000 match is for the development of a trailhead and parking lot. County Parks will have two years to complete the funded projects.

The other applications that were submitted for the North Channel County Park were for an EGLE (Environment, Great Lakes, and Energy) grant that would help fund a protection wall on the shoreline. This "soft" shoreline stone wall would provide



Another Natural Resource Trust Fund Grant application was submitted for a phase II of North Channel County Park. The award decisions for this grant will be made in the spring of 2024. This grant would help to construct a restroom, pathway and fishing/observation pier. The request is for \$300,000 with a \$300,000 match.

Recently a SPARK grant was also applied for. Funds would be used for the purchase and installation of inclusive play features at North Channel County Park. Local match will come from annual millage allocation and/or private and public donations. This request was for \$200,000 with a \$25,000 match.

Bridge to Bay Trail

Trail Expanded with Campus-Canal Pedestrian Bridge Addition

There are multiple trail projects underway edging St. Clair County closer to connecting and completing gaps in the Bridge to Bay Trail, our region's longest pedestrian trail.

A ribbon cutting ceremony was held June 7th for the Campus-Canal Pedestrian Bridge. This pedestrian bridge over the Black River Canal connects Port Huron Northern High School and Holland Woods Middle School campuses and bridges Fort Gratiot Township to downtown Port Huron. Three new trail projects are in various stages of construction this year; the Clinton Avenue route in St. Clair, River Road and Davis Road extensions in Marysville, and a bike path on Gratiot Avenue in Port Huron. Currently we are working with communities in the southern part

of the county to begin engineering and design phases of three new trail projects; Marine City's Downtown Loop, an Algonac State Park connector through Cottrellville Township, and a safe bike boulevard through Algonac.

Additional trail projects include a \$50,000 grant from the Ralph C. Wilson, Jr. Legacy Fund administered by Friends of the St. Clair River to install trail kiosks, signs, and way-finding markers in communities along the trail. Look for these to be installed later this summer and fall.

Completion of Will Bendik Memorial 18-Hole Disc Golf Course

welcome. We are excited for the community to come and explore the new trail!



New Park Access Road

A new access road has been added to help park patrons navigate Goodells County Park more easily. Fort Gratiot Light Station

Lantern Room Restoration





The Fort Gratiot Lighthouse Lantern and Watch Room Restorations were made possible through the Michigan Lighthouse Assistance Program (MLAP). The St. Clair County Parks and Recreation Commission has wrapped up the project in 2022, restoring the Watch Room and Lantern Room within the Fort Gratiot Lighthouse. Extensive work was done on the Lantern Room, Watch Room, and landing areas to repair and bring them back to their original historic appearance.

The Lantern Room had all non-historic materials removed exposing the original tin ceiling and vent. All the original interior and exterior surfaces were cleaned, repaired, and repainted and new 3/8" tempered glass panels were installed in the original openings. The most unique change was the removal of the wood floor that was added in the 1940s. With the floor removed, visitors now can see into the Lantern Room from the Watch Room below.

In the Watch Room, much-needed repairs were done to the interior brick walls using the correct mortar and then a special masonry coating was applied. Ventilation ports were cleaned out and the historic brass louvers were restored to function properly, which are crucial to air circulation. The iron flooring, ceiling, and ladder to the Lantern Room were stabilized, repaired, and repainted to restore their 1930's appearance.

The landing below the Watch Room had extensive repairs made as well. A unique built-in storage cabinet was repaired and replica wood doors were made to match the original openings. The cabinet will securely

hold artifacts and replicas to enhance interpretation of the keeper's duties. Missing doors on the clock weight cavities were replicated and installed along with the missing weight slot shelf.

The project was made possible through grants from MLAP, awarded by MSHDA in the spring of 2021, and a local grant from the Friends of the Fort Gratiot Light with the remaining funds coming from the St. Clair County Park millage.

The Fort Gratiot Lighthouse is a historic structure. All work was done in compliance with the Secretary of the Interior's "Standards for the Treatment of Historic Properties" and with guidance from the State Historic Preservation Office.

Save the Date! SandFest Returns for 2023

The annual Blue Water SandFest will be held August 4-6 at the Fort Gratiot Light Station. As Michigan's first master and amateur sand sculpting competition and festival, the event raises money each year for the restoration of the Fort Gratiot Light Station. This year's event will include master and amateur sculpting competitions, sand sculpting demonstrations and lessons, kid's zone, food trucks, beer garden, live music, and corn-hole tournament.
