# St. Clair County Parks Maintenance Millage on the Ballot

This year marks the 30th year that the St. Clair County Parks and Recreation Commission (PARC) will distribute 25% of the County Parks and Recreation millage funds collected back to the local units of government.

The current millage rate is .4944 mils for 6 years. This adjusted millage rate is slightly less than the original .5 mils levied in 1995. The existing millage will generate approximately \$3,692,722.12 in 2024 for parks and recreation facilities and programs, with \$923,180.53 going back to 33 local units of government through the local millage distribution program.

In August 2024, an additional .4944 maintenance millage is being proposed for three years, expiring in 2027, the same year as the existing millage. If voters approve the additional millage, the owner of a house assessed at \$100,000 will pay approximately \$50 per millage for a total of \$100 a year. Both millages will expire in 2027. This would provide an additional \$3,692,722.12 for needed maintenance of existing park infrastructure. It would also increase the local millage distribution program by \$923,180.53.

# **Millage Distribution**

St. Clair County Parks and Recreation Commission was the first in Michigan to utilize the millage distribution plan. By giving back to 33 local municipalities, each unit of government receives 25% of millage funds received to be used to expand recreation opportunities in their communities. Since 1996, St. Clair County Parks and Recreation millage funds have provided \$19,957,838.12 to local units of government for parks and recreation projects.

The 2024 Local Millage Distribution table (located to the right) includes the 2020 census figures used to calculate each community's share; the amount of millage funds that will be distributed to each community in 2024; and the amount of projected funds that could be distributed to each local unit of government each year if the proposed millage passes.

In order for the 33 local units of government to receive their annual share of the County Parks and Recreation millage funds, each community's governing board must approve the submission of an annual Local Millage Distribution request form that outlines how the community has spent their share of the millage funds during the past year.

# **Unique Facets of St. County Parks**

### **Features & Assets**

St. Clair County Parks and Recreation Commission has several unique features in each of its nine parks and trails. Fort Gratiot Light Station boasts the oldest lighthouse in Michigan (1829), Goodells County Park offers an 11-spray feature Splashpad, and the Wadhams to Avoca Trail has the longest trestle train bridge of its kind (640 feet). Wedding ceremonies, receptions, graduation parties, birthdays, stages and bleachers, and other special events make up over 1,400 rentals on average per year in our parks. Each park offers its own unique amenities, giving the community several options for recreation.

# **Goodells County Park**

# **Park Progress and Infrastructure**

In 1909, St. Clair County established its first county park in Goodells, with early development taking place in the 1920s. The park expanded across the road in the late 1990s, adding the land that was once home to the county farm and medical center. The park has strong rural and agricultural ties, having been home to the 4H County Fair for over 80 years and to the SCC Farm Museum since 1966. The 366-acre park has over 30 facilities, which include the Visitors Center, two accessible playgrounds, six picnic shelters, three Exhibit Barns, the Exhibition Barn, the Community Center, a historic village, two museums, a BMX track, a radio-controlled model airplane airfield, a butterfly garden, river and fishing access, a seasonal ice-skating rink, mountain bike trails, Splashpad, equestrian facilities, and meadow areas for outdoor events.

# **Columbus County Park**

# **Park Progress and Infrastructure**

In 2007, the St. Clair County Parks and Recreation Commission acquired Columbus County Park, the largest of the St. Clair County Parks. Facilities at the park include an energy-efficient park lodge with modern restroom facilities, a picnic pavilion, offices, and storage rooms. Activities at the park include picnics, weddings, educational programs, meetings, a sledding hill, mountain biking trails, walking trails, horse trails, permit-only hunting, and an 18-hole disc golf course. The beautiful Belle River meanders for 1.6 miles through the park and provides fishing access. Near the entrance off

Bauman Road is a restored historic gambrel roof barn, currently being used for maintenance and storage.

# Wadhams to Avoca Trail

# **Park Progress and Infrastructure**

Beginning in 1999, St. Clair County Parks began developing the Wadhams to Avoca Trail. Previously owned by CSX Railroad, PARC purchased the surface rights between Griswold Road and Avoca Road, stretching over 12 miles in length and 160 acres. The centerpiece of the trail is the 640-foot long Mill Creek Trestle. Built in the late 1800's, the 60-foot high trestle has been decked and railed with four overlook areas that provide beautiful views and safe access for walkers and bicyclists. The non-motorized trail is open to walkers, bicyclists, and equestrians. Designated off-road parking areas are located at Wadhams Road, Lapeer Road, Imlay City Road, and Avoca Road Trailheads.

# Blue Water River Walk County Park

# **Park Progress and Infrastructure**

The Blue Water River Walk will be celebrating its 10-year anniversary this year! Owned by the Blue Water Land Fund through the Community Foundation of St. Clair County and leased to the St. Clair County Parks and Recreation Commission, the Blue Water River Walk is open to the public year-round. Formerly a railroad switch yard, the shoreline has been restored to coastal wetlands, is home to natural habitat such as frogs, turtles, and toads, and is a popular nesting and feeding spot for migratory birds. At the southern end is the almost 5-acre county owned park

and wetlands. The park features include an observation deck, a pedestrian trail, an outdoor classroom, shoreline and habitat restoration, a fishing pier, and public art.

# Fort Gratiot County Park

### **Park Progress and Infrastructure**

In 2005, St. Clair County Parks purchased Fort Gratiot County Park and began development in 2006. Today, the 30-acre park bustles with beach-goers during the summer months, offering breathtaking views of Lake Huron and over 850 feet of beach shoreline. Park facilities include restrooms, a playground, picnic tables, grills, two picnic pavilions, a canopy tent, paved walking trails, and a ceremony plaza on the beach overlooking Lake Huron.

Fort Gratiot County Park is also home to the 1971 Tunnel Explosion Memorial, which commemorates the construction accident that took the lives of 22 men working on the water intake tunnel located beneath the park.

# **Park Progress and Infrastructure**

The oldest lighthouse in Michigan! The Light Station property was officially transferred to St. Clair County in 2010. Restoration of the lighthouse was completed in 2013, and other property repairs and additions have been made using Michigan Coastal Management Program grant funding and the Michigan Lighthouse Assistance Program. Friends of the Fort Gratiot Light Station raise funds for building restoration projects and provide volunteers with events such as the Blue Water Sandfest. They recently donated funds to replace 44 windows in the Retired Coast Guard Station, as well as 16 windows in the

Keepers Duplex. The tower reopened for tours in the summer of 2012, with the Port Huron Museum serving as a partner in leading tours of the site, programming, and private reservations.



# **North Channel County Park**

# **Park Progress and Infrastructure**

In 2021, St. Clair County was awarded grants to purchase property on the North Channel in Clay Township. The long-awaited project, in partnership with Six Rivers Land Conservancy, Clay Township, and the City of Algonac, is finally underway. The development of North



Channel County Park is on track to begin this fall. Fishbeck Engineers/Architects were awarded phase one of the site design, which includes a parking lot, trailhead, and park pavilion. Phase one is being funded by a \$270,000 Natural Resource Trust Fund Grant and a match of \$280,000 coming from the County Parks millage fund.




