

River Walk County Park to Take Shape This Summer



This spring, a \$665,300 contract was awarded to Raymond Excavating of Marysville to construct phase one of the Blue Water River Walk park improvements. The park is located just north of the County Wetlands and next to the Blue Water River Walk.

Park improvements will include a picnic pavilion, a shade trellis, walkways, landscaping, an artificial turf activity area, picnic tables, grills and benches. Construction is expected to start in June and should be completed by the end of September.

The project is being funded in part by a \$75,000 DNR Recreation Passport grant and a \$300,000 Michigan Natural Resources Trust Fund grant. Both grants are being matched with funding from the St. Clair County Parks and Recreation millage.



Park News

County Park Connections: CISMA

In 2015, the Lake St. Clair (LSC) Cooperative Invasive Species Management Area (CISMA) was established within the Macomb and St. Clair County portion of the Lake St. Clair watershed. The LSC CISMA works to prevent, detect, monitor and control invasive species within its boundaries. The LSC CISMA works cooperatively by partnering with local government agencies, non-profit organizations and volunteers to help stop the spread of five priority invasive species and reduce their associated ecological, public safety and economic stressors.

The LSC CISMA coordinated treatment efforts along the Wadhams to Avoca Trail in 2018. Phragmites australis, commonly known as phragmites or common reed, was the target plant managed. Phragmites is an aggressive perennial grass that can grow over 15 feet tall. Stems are hollow and leaves are a dull, blue-green in summer. When dormant or dead, phragmites stems will remain standing and turn yellow-brown. Dense phragmites are difficult to eradicate. Controlling it before it becomes established is critical to reducing environmental impacts and treatment costs. Community Service Award

Volunteers are critical to the success of operations within our St. Clair County Parks. Recently we were able to honor one of our local groups by nominating them for a mParks Community Service Award. The program recognizes volunteers from around the state of Michigan who donate their time and resources to Parks and Recreation. This year, Master Gardeners of St. Clair County received a Community Service Award at a ceremony in East Lansing. Master Gardeners recorded over 200 volunteer hours last year. The hours were spent maintaining numerous flower beds, managing the native plant garden at Goodells County Park and removing invasive species at multiple parks. Congratulations to the Master Gardeners on receiving the 2019 mParks Community Service Award!



Trails Study Update

Last June, St. Clair County received a \$39,288 grant from SEMCOG, as well as a \$24,453 grant from the Community Foundation of St. Clair County, to update the County's Trails Strategy and Action Plan that was last developed in 2008. Since that time, the County has worked with its consultant SmithGroup to identify all remaining gaps between existing trail sections and has worked collaboratively with local communities to identify route connections to close those gaps. Through this process, over 130 trail segments have been identified and mapped in order to complete the Bridge to Bay Trail and connect it to the Wadhams to Avoca Trail and the Macomb Orchard Trail in Richmond.

SmithGroup is wrapping up the Trails Strategy and Action Plan in May. In addition, the Metropolitan Planning Commission has completed its conditions analysis of the existing trail network, evaluating pavement conditions and long-term maintenance needs that will be crucial for ensuring sustainability of our trail system. Parallel to this work, the Community Foundation hired Public Sector Consultants to complete an economic impact study on regional trail systems that will help St. Clair County implement our Trails Strategy and Action Plan in a manner that utilizes best practices and lessons learned from other successful regional trail systems. County Parks Are Smoke-Free!

Last fall, the St. Clair County Board of Commissioners approved a change to the park rules regarding smoking in all County parks and trails. The new rule is an extension of the playground and Splashpad smoking ban that was put into place a few years ago. The rule covers all tobacco and vaping products. We appreciate everyone's cooperation in making our parks and trails smoke-free!

New Pavilion Work Completed

Construction of the new pavilion near the Goodells County Park Splashpad has been completed along with landscaping. The \$90,000 wood pavilion is 40 ft. by 44 ft. and has ten picnic tables, two buffet tables, a group picnic grill and electricity. The construction of the pavilion was funded entirely by the St. Clair County Parks and Recreation millage. Earth Fair a Success

Earth Fair continued for its 17th straight year on April 26 & 27 at Goodells County Park, remaining Michigan's largest Earth Day celebration. This 2-day event inspires 6,000 visitors every year to learn about the significant role we play in the health of our economy and environment by challenging visitors to participate in its low-waste, low-emission, smoke-free setting. This year Earth Fair hosted 80 vendors, demonstrations, workshops and activities and 1,200 students on a free field trip to promote and augment the science lessons taught in the classroom.

1st Floor Duplex Work Wrapped Up

Collaboration is a great way to describe the work completed in the south half of the Keeper's Duplex. This winter, contractors, park staff and volunteers wrapped up the restoration of the parlor, sitting room and hallway. The major restoration project included demolition of all renovations that were done back in 1966.

R & D Foglesong construction moved interior walls back to their original locations then added historically accurate windows, doors and detailed trim. They also returned the stairwell banister to its original wrap around configuration. TNT Electrical re-routed and replaced the electrical wires and outlets. Soulliere Drywall did repairs to the original plaster and installed replacement drywall. Superior Heating and Cooling removed the modern baseboard heaters and added historically accurate radiators. Park staff carefully restored the original red oak flooring and, volunteers from the Friends of the Fort Gratiot Light painted the walls and trim. The replicated banister was painted by Donnelly Painting with a beautiful faux finish to match the original colors.

The work was capped off with the Port Huron Museum adding historically accurate furnishings. The project was funded by the Friends of the Fort Gratiot Light.



This summer, students from Central Michigan University will conduct an archeological dig on the grounds of the Fort Gratiot Light Station. The students will be targeting several areas that may provide clues related to life at the station in the 19th Century. One particular target is the foundation of the original Keeper's Dwelling that was built in 1829 and demolished for the Duplex in 1873. The artifacts collected will be analyzed, documented and then returned to County Parks for future interpretation.



Great Lake to Lake Trail

St. Clair County is one of nine Michigan counties working together with the Michigan Trails and Greenways Alliance, MDOT and MDNR to create and manage the Great Lake to Lake Trail Route #1. The route will connect 16 local trails including the Bridge to Bay Trail and will run from South Haven on Lake Michigan to Port Huron on Lake Huron. The eastern endpoint for the trail will be Port Huron's Lighthouse Park. For more Information, visit https://michigantrails.org/trails/great-lake-to-lake/

Gratiot Road Connector Trail

The construction of the new Gratiot Road trail extension from the Park-N-Ride lot under I-94 to Pickford Road is expected to start in May and be completed by July. The nearly \$219,000 construction project is being funded by a \$159,500 Transportation Alternatives Program grant from MDOT and the local match is being funded with St. Clair County Parks and Recreation millage funds.

Wadhams to Avoca Trail

Trail Maintenance

Park work crews were back on the Wadhams to Avoca Trail last fall and winter trimming back aggressive underbrush and trees. The Phragmites plants that were not killed in previous treatments were treated again in September. Some areas of the tall dead grasses were mowed to allow the native plants to return to the trail corridor.

If trail users see any downed or leaning trees along the trail, they are encouraged to call the parks and recreation office at (810) 989-6960 to report the location of the trees.



Celebrating 20 Years: 1999-2019

Twenty Years. Time flies when you are blazing a Trail! The year was 1999 when St. Clair County Parks began the mission of developing a unique rail trail for multi-use. The trail's growth will not end there. The future may include an extension to Yale and connections to the Bridge to Bay Trail.
